



# Broadmeadows Farm, Yarrowford by Selkirk 1 Day Enduro

# 20th September 2009

On the next few pages you will find the regs and entry forms for the above Enduro. At the end is the Parental Agreement Form for riders under 18yrs and our Membership Form for those of you that wish to join the club – but it is not necessary as long as you have an ACU or SACU Enduro Licence. If you wish a day licence you must be a member of a club affiliated to one of these two organisations and bring with you your membership card, or else we are sorry you will have to join ours on the day – no membership card, no day licence.

<u>Last Posting Date</u> – you will note that we have included this as we will be unable to accept late entries – if I don't have fully completed entry forms and entry fee **by Wednesday 16 September 2009**, you will not be included. So please remember <u>POST THEM FIRST</u> <u>CLASS BY Monday 14 September 2009 we will not collect undelivered post from the post</u> <u>office, you must ensure you have the correct value of stamps on your envelope.</u>

<u>Preferred Rider No</u>: If you have a number on your bike and would like to keep it just put a note on your entry and I will try to give it to you if possible. However perhaps it is worth bearing in mind that the earlier you get your entry in the higher up the riding order you are in your class as only Rider numbers 1, 2 and 3 have been requested by the SACU to be set aside.

<u>Rider Numbers & Results</u>: We will not be posting out rider numbers these will be posted on the Scottish Enduros <u>http://www.scottishenduros.co.uk/</u> and Melville <u>http://www.melvillemc.co.uk/</u> websites on 09 September and final listing on 17 September, get your entry in early if you need your number quickly. Results will be posted in the same way as soon as possible after the event.

<u>Information from the SACU:</u> Once again for 2009 clubs are to remind riders that there is no temporary disablement insurance carried on the event insurance. You can obtain one event – or full season insurance on a personal basis by applying to Alexander Forbes Motorsport Risk Services – Tel 0161 228 0721 or e-mail to <u>lubyd@aforbes.co.uk</u>. Clubs must check that any non ACU or SACU riders have appropriate start permission from their respective Unions eg MCUI of Ireland. This ensures they have repatriation insurance in case of injury. If this effects your entry please bring it to our attention.

<u>Attention Novice Riders</u> – remember whatever time you finish your riding for the day make sure you hand in your timecard at the start check because it is the only way we know that you are safely off the course and until we can account for each and every rider, by having all the timecards, the organisers, marshals and first aiders cannot go home.

<u>Clubman</u> – The well established 3 classes of E1, E2 & E3 remain unchanged.





E1, E2 and E3. We will have two sets of results – the full Clubman one and a set separated into the 3 classes – There will be a trophy for the winners of each of the 3 classes. Details of the different classes as follows:-

- E1 up to 125cc 2 stroke & up to 250cc 4 stroke
- E2 126cc to 250cc 2 stroke & 251cc to 450cc 4 stroke
- E3 Over 250cc 2 stroke & over 450cc 4 stroke

There is no change to Clubman B class (no capacity constraint) with it's own trophy, the intention of this class is to allow the more able sportsman riders to move up to the clubman class, there will be the same number of laps as E1 to E3 but with more time to complete each lap, so if you currently ride sportsman and need to challenge yourself a bit more, go for it! Within the Clubman B Class there will be a sub class for over 50's, many of our ex champions are eligible for this class so do not think winning will be easy.

There will be a designated area for camping on Saturday night. Bikes must not be started between the hours of 6.30pm and 9am on Saturday or Sunday. The camping / paddock area is directly adjacent to our host community, please act with respect by keeping noise, especially in the evening to a minimum, and take your litter home.

For those using Sat Nav to find the event the post code is TD7 5NA

#### Venue:-

#### Broadmeadows Farm, Yarrowford, West of Selkirk on the A708. Post code TD7 5NA.

Assembly/Signing on will be at 9.00am.

- Scrutineering from 9.00am 10.00am. Penalty for late scrutineering 60 points.
- First man leaves at 10:30am.

#### Route:-

Approx 25 miles over open farmland, woodland and open moor, marked by tape, rope and Day-Glo arrows.

#### Eligibility:-

- Expert, Clubman E1, E2 & E3, Clubman B (incl over 50's), Over 40's and Sportsman classes.
- One-day Licenses will be available only on production of proof of your Club Membership.

#### Entries:-

Completed entries to be returned to – Mrs Valerie O'Neill, 31 Chester View, Bonnyrigg, Midlothian, EH19 3PU. Please do not include Stamped Addressed Envelopes rider numbers and results will be posted on the Scottish Enduros and Melville Web sites) Finally Remember your licence number and Melville Club membership if applicable!

Entries and fees will not be returned unless the event is cancelled or a rider gives a valid reason for not riding at least seven days prior to the event. In such cases  $\pounds 10$  will be deducted to cover costs. Any rider not signing on, on the day, will forfeit his entry fee in full.

#### Entries close on Wednesday 16 September 2009 or when full. <u>No late entries will be accepted</u>. LAST FIRST CLASS POSTING DATE: Monday 14 September 2009.

#### Scrutineering:-

Riders must sign on prior to scrutineering. Riders must present their machines along with an ACU approved stamped helmet, a dog tag (I.D. Disc with Name, Date of Birth and Blood Group, if known). Note: Helmets will be checked again at start line (So those of you who present a different helmet for scrutineering than what they actually use to race will not be allowed to start). Please ensure you have correct colour of background and numbers for you class.

#### Starting:-

Each rider will receive a time card at signing on for the days run. At the beginning of the enduro collect your machine from the Parc Ferme just before your start time. Present your machine on the start line at your due time. DO NOT START your engine before your start time. On your minute – start the machine and proceed around the course. If you are not at the start line at the appropriate time you will not be penalized providing you bring your machine to the start line, start it and cross the 20 metre line within one minute of your designated start time. If you exceed this one-minute you will be penalized 20 points. You

may then start your machine in any manner you desire, but you must cross the start line before proceeding en-route.





#### Refuelling:-

- Must only take place in designated areas, between white and yellow flags and between check and green flags.
- All crews must provide a fire extinguisher.
- Each machine should be refuelled on an environmental mat.
   NO SMOKING AND NO MOBILE PHONES IN THIS AREA!

#### Time Checks:-

- Will be marked with a white flag at 200m and a yellow flag 20m before the check.
- You must not pass the yellow flag to check in before your designated time.
- Timing as per British Championship.

#### Special Test:-

This will be available for viewing from the Saturday evening, access is pedestrian only from the parc ferme / camping area, dogs must be kept on a lead.

Riders must stop at the start of the test sign "A". The end of the test, indicated by sign "B", will be of the flying finish type and riders need not stop.

#### Environmental:-

The use of power washers, anywhere on the farm, is strictly prohibited. Any rider or member of their support team found in breach of this rule will have the bike and rider excluded from the event.

<u>All Riders (and their support team) must, when refuelling or maintaining their bikes, use an environmental mat, (eq piece of carpeting).</u>

#### General:-

- Any unauthorized person found riding a motorcycle or other vehicle on the farm at any time before or after the event will be reported to the relevant authorities and excluded from this and subsequent Melville events.
- At all times competitors and their support crews must give way to other farm users. Stop and switch off engines if necessary.
- No dogs unless under control and on a lead at all times.
- Please take your litter home and respect the Country & Sporting Codes.
